

## DIRECTIONS TO THE TEST SITE:

**From the North:** I-95 or NJ Turnpike south over the Delaware Memorial Bridge. Take Exit 279 (Elkton) to Route 213 North. Follow Route 213 North to Route 273. Turn right (east) on Route 273, past the racetrack, under a bridge to the next right on Gallaher Road. Go approximately ½ mile to the site on the left at the insection of Big Elk Chapel and Gallaher Road.

**From the South:** I-95 north to Exit 100 (North East). Turn left off ramp onto Route 272 North. Follow Route 272 North to Route 273 Turn right (east) on Route 273. Continue straight after the light at Fair Hill (Route 213), go past the racetrack, under a bridge to the next right on Gallaher Road. Go approximately ½ mile to the site on the left at the insection of Big Elk Chapel and Gallaher Road.
